This is a restricted call for Green Recycling Enterprises Engaging in New Technology for a Circular Economy in Zambia (GREENTech4CE). The intervention logic of the GREEN Tech4CE project is based on a market systems approach aimed at overcoming the challenges MSMEs face to develop a sustainable green, circular, and digital (GCD) economy. The project intends to enhance MSMEs' capacities through technical assistance and financial support, linking value chains associated with critical raw materials and increasing market awareness and access for GCD products. By improving the availability and diversity of financial products for MSMEs and fostering public-private learning and policy advocacy, the project seeks to attract more investments and facilitate MSME growth in Zambia's GCD economy. The project involves collaboration with various stakeholders, including the government, businesses, and consumers, to foster sustainable and positive changes in the green economy. It employs a blended financing model, combining project funds with business contributions to stimulate further investment and commitment.

Eligible applicants will be required to submit full proposals which shall be evaluated based on their alignment and compatibility with the green circular and digital (GCD) economy objectives. Existing start-ups and micro-enterprises which are active in the GCD economy and/or have potential to transition existing activities into GCD activities will be identified
